Supervisor Simon called the October Board Meeting to order at 7:00PM.

PLEDGE OF ALLEGIANCE

PRIVILEGE OF THE FLOOR ON AGENDA ITEMS ONLY

Richard Pucher, Town of Yates, responded to a prior statement made by Councilman Bradley at last month's Board Meeting by saying that the Town was sent a bill due to the SOS Bane MET Tower Lawsuit for slightly over \$15,000 and all but slightly less than \$30.00 was reimbursed by APEX.

Paul Lauricella, Town of Yates, questioned Resolution No. 86 and the tentative budget and asked where the Board stood on taxes.

Supervisor Simon responded that his goal was to stay considerably under the tax cap and to keep the rate as flat as possible.

Paul Lauricella responded that he would like to see a decrease in the tax rate if possible. He also questioned Resolution No. 89 and asked what equipment was being sold, is it junk, and who it will be available to.

Supervisor Simon said that one truck will be sold for scrap and that he thinks the other one will be sold at Municipal Auction.

Paul Lauricella asked where the funds from the sale of highway equipment will go. He also requested that the bills that are paid monthly be outlined and available to the public with totals for each fund account so that residents can see where their money is going.

Supervisor Simon responded that he believes that the funds would go back into the DA account but will check into it. He will also consider a way to list the amounts of the bills broken into fund accounts, if possible.

Steve Royce, Town of Appleton, questioned Resolution No. 92 and asked if the Board would expand upon the nature of the letters.

Supervisor Simon explained that they had received 2 letters from Young Sommer LLC, one on the 6th of October and another on the 10th of October. He added that the letters have been forwarded to Hodgson Russ and that Special Counsel, Dan Spitzer, is in the process of reviewing and responding to them. There is disagreement between Hodgson Russ and Young Sommer as to whether or not the vote at last month's meeting was a denial of the Austin MET tower application or if it requires another vote, since the vote was split. This is also being reviewed.

Harvey Campbell, Town of Yates, asked if Resolution No. 91 was a leash law.

Supervisor Simon responded that the County is in the process of passing County-wide dog control laws. He explained that a while back the Yates Board was approached by someone that was having issues with coyote hunter's dogs crossing property boundary lines. He added that the Board should wait to see the language in the County law before passing their own local law because the County law would supersede the Town's law.

PRIVILEGE OF THE FLOOR

Paul Lauricella, Town of Yates, asked if there would be budget copies available at the Public Hearing for residents to review. He added that the County makes them available at their hearing.

Supervisor Simon said that we'll have a few copies printed and available for review.

Richard Pucher, Town of Yates, asked if the audit was approved last month and if there were any deficiencies. He added "then the bookkeeper is doing a good job".

Supervisor Simon responded that the audit report was accepted at last month's meeting and said that the only "ding" was the amount spent on legal services. He added that yes, the bookkeeper did a good job.

Agnes LaPorte, Town of Somerset, submitted a letter where she addresses Secretary Burgess and the Public Service Commission discussing the proposed Lighthouse Wind Project and her opinion that it would destroy lives and force many to move out of state. She also said that the Event Tracking Log submitted by Lighthouse Wind from May – June 2017 notes attendance information that is not correct. She submitted the logs and noted the inconsistencies.

James Hoffman, Town of Somerset, submitted an article written by a Sheldon Town Councilor with regard to the High Sheldon Wind Farm where the Councilman outlines the negative impacts the Town and its residents have experienced such as noise, shadow flicker, health issues, loss of property values, electromagnetic interference and overall complaints. He added that "living among turbines is vastly different than a few hour visit on a nice afternoon."

Susan Campbell, Town of Yates, stressed that not everyone that supports the wind project will be benefitting financially. She lives in the Village of Lyndonville and cannot sign a lease but would love to have one to be able to help support the future of our children and the future of our earth.

Donn Riggi, Town of Yates, said that if we care about the future of our children and grandchildren then we should look for alternate energy sources that do not leave such a large carbon footprint like solar or geothermal energy.

Betty Wolanyk, Town of Somerset, submitted some findings from her recent research into the economic impact on rural communities due to industrial wind turbines. Some of these include: no economic growth, negative impact on tourism, turbines using more power then they generate causing price surges and a decline in property values.

Harvey Campbell, Town of Yates, wondered whether or not any of the members on the Board have addressed the recent sewage dumping into Lake Ontario in Niagara County. He asked if they have talked to the DEC and asked for an official statement by the Board.

Supervisor Simon said that the Village does a great job with their water plant.

Harvey Campbell said that this concern should be addressed at the Board level.

Richard Fisk, Town of Yates, said that as the Board tackles the budget process it would be made much easier with the \$650,000 that APEX would pay toward it each year for the next 20 years. He added that we don't need to listen to studies done in Australia, we can check out the Maple Ridge Wind Farm in Lowville where business is growing and the schools are doing well with the money they receive from the wind project.

Linda Fisk, Town of Yates, stressed that even with the "threat" of a pending wind farm, a lot of homes in the Town of Yates have sold recently.

Paul Lauricella, Town of Yates, asked if the proposed new business on Route 18 is a dead proposal.

Supervisor Simon said that there has been no movement there recently.

Councilman Whipple added that the project is not dead. He said that no financial assistance will be available to the business owner until he moves forward with his plans and that there are no requirements that hold him to his original proposal; he can walk away if he so chooses.

Councilman Bradley reread a prior statement made by him at the September Board meeting where he said "The Town received a bill in the amount of \$27,000 for the legal defense of that lawsuit".
