Failure to pick up and remove litter and clean area after use will forfeit the return of your Security Deposit and/or future use of the facility. The Security Deposit will be refunded upon satisfactory inspection of the facility.

- The pavilion may be reserved by contacting the Yates Town Clerk at 585-765-9716, submitting the Rental Application and paying the Security Deposit and Rental Fee.
  - The Security Deposit and Rental Fee for the pavilion are refundable up to 48 hours before the reserved date, but are nonrefundable if cancellation occurs within 48 hours of the reserved date.
  - The restrooms in the pavilion are authorized for any person to use even if the pavilion is reserved.
  - NO smoking and NO alcoholic beverages are authorized without explicit Yates Town Board approval.
  - Nails, thumbtacks, staples, etc. may not be used on the pavilion or picnic tables. Masking and transparent tape are allowed. All decorations must be removed at the end of the event.
  - No vehicles or ATV's are allowed on the grass.
  - When the pavilion is reserved, a RESERVED sign will be prominently posted on the pavilion and only the person or organization reserving the pavilion will be authorized to use the facility. If there is no RESERVED sign on the pavilion, it is open for public use on a first-come, first-serve, space available basis.
- Renters are encouraged to bring their copy of this rental agreement to the park the day of their rental.

**Indemnification Statement:**
